

## Flights of Flavor Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Flights of Flavor (the "Promotion") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of HV Food Products Co. ("Sponsor"), Merkle Inc. ("Administrator"), each of their respective parent, subsidiary and affiliate companies and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and household members, whether or not related, of each such employee are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**3. Timing:** The Promotion begins on April 4, 2022 at 1:00 p.m. Pacific Time ("PT") and ends on June 23, 2022 at 1:00 p.m. PT (the "Promotion Period"). Administrator's servers are the official time-keeping device for the Promotion.

**4. How to Enter:** The Promotion consists of an instant win game (the "Instant Win Game") and a collect and win game (the "Collect and Win Game"). During the Promotion Period, visit <https://www.hiddenvalley.com/ranchology-rewards-program/> and follow the links and instructions to register (if you have not done so previously) or log in to your account. If this is your first visit to the Hidden Valley site, you will be required to provide your name, email address and password as well as agreement to the terms of the site (<https://www.thecloroxcompany.com/terms/>) to register. In addition, you will be required to review and confirm agreement to these Official Rules.

**Instant Win Game:** Once you've registered (or logged in), follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be displayed at the time of play. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

**Collect and Win Game:** Each time you play the Instant Win Game during the Promotion Period and do not win, you will receive one (1) Collect and Win Game piece in the form of a virtual token (each, a "Game Piece"). You can track your progress by logging in to the Promotion Site and viewing your gameboard.

For Instant Win Game and Collect and Win Game: Each entrant may earn up to one (1) Instant Win Game play per day until he/she has won a Collect and Win Prize. **6. Collect and Win Game/Instant Win Game Prize Selection and Verification of Potential Winners:** All selected potential winners must comply with all terms and conditions of these Official Rules, and all winnings are contingent upon fulfilling all requirements. Administrator is an independent judging organization whose decisions as to the administration and operation of the Collect and Win Game and the Instant Win Game and the selection of potential winners are final and binding in all matters related to the Promotion. Instant Win Game: There will be two hundred fifty (250) random, computer-generated winning times during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the randomly generated times, you will be a potential instant winner of the prize indicated. Each Rare Game Piece will be associated with a random, computer-generated winning time during the Promotion Period. If you are the first player to play the Instant Win Game at or after the randomly generated winning time you will be awarded a Rare Game Piece. Once you have collected all five (5) Game Pieces for the applicable Prize Type, you will be a potential winner of the applicable Prize Type.

If any potential winner cannot be contacted, fails to provide any other requested information within the required time period, or if prize is returned as undeliverable, potential winner forfeits prize.
