

## Ranchology - Lucky Draw Dinners Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Ranchology - Lucky Draw Dinners (the "Promotion") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of The HV Food Products Co. ("Sponsor"), Merkle Inc. ("Administrator"), each of their respective parent, subsidiary and affiliate companies and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and household members, whether related, of each such employee are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**3. Timing:** The Promotion begins on March 6, 2023 at 1:00 p.m. Pacific Time ("PT") and ends on May 26, 2023 at 1:00 p.m. PT (the "Promotion Period"). Administrator's servers are the official time-keeping device for the Promotion.

**4. How to Play:** The Promotion consists of an instant win game (the "Instant Win Game") and a collect and win game (the "Collect and Win Game"). During the Promotion Period, visit <https://www.hiddenvalley.com/ranchology-rewards-program/> and follow the links and instructions to register for Ranchology® Rewards (if you have not done so previously) or log in to your account. If this is your first visit to the Hidden Valley site, you will be required to provide your name, email address and password as well as agreement to the terms of the site (<https://www.thecloroxcompany.com/terms/>) the terms of the Ranchology® Rewards program, and the Clorox privacy policy to register. In addition, you will be required to review and confirm agreement to these Official Rules. Then, navigate to the "Promotions" tab and the "Lucky Draw Dinners" tile and click "Play Now". Once on the promotion site, users may click on one of five cards to reveal a Lucky Draw Dinners recipe. Once a card has been selected, the Instant Win Game results will be instantly displayed and will notify the user if they are a "winner" or not of the Instant Win Game. Players may play the game once per day throughout the promotional period for a chance to win an Instant Win prize. Each time you play the Instant Win Game during the Promotion Period and do not win, you will receive one (1) Collect and Win Game piece in the form of a virtual token (each, a "Game Piece"). You can track your progress by logging in to the Promotion Site and viewing your gameboard. Users can collect recipe cards throughout the Promotion Period. Users who collect all five (5) recipe cards will win the Collect & Win prize. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

**Limit: For Instant Win Game and Collect and Win Game: Each entrant may earn up to one (1) Instant Win Game play per day until he/she has won a Collect and Win Prize; winners will be notified during the game play and will receive an email confirmation from the Administrator of their win. Winners will be asked to provide their contact information to claim their prize(s). Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses**

for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.

**5. ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR OR ADMINISTRATOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION. AN ENTRANT IS NOT A WINNER OF ANY PRIZE, EVEN IF THE INSTANT WIN GAME OR COLLECT AND WIN GAME SHOULD SO INDICATE, UNLESS AND UNTIL ENTRANT'S ELIGIBILITY, AND THE POTENTIAL INSTANT WIN GAME WINNER AND/OR COLLECT AND WIN GAME WINNER HAVE BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE. **6. Instant Win Game/Collect and Win Game Prize Selection and Verification of Potential Winners:** All selected potential winners must comply with all terms and conditions of these Official Rules, and all winnings are contingent upon fulfilling all requirements. Administrator is an independent judging organization whose decisions as to the administration and operation of the Instant Win Game and the Collect and Win Game and the selection of potential winners are final and binding in all matters related to the Promotion.

Instant Win Game: There will be six hundred (600) random, computer-generated winning times during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the randomly generated times, you will be a potential instant winner of the prize indicated.

Collect and Win Game: Each Collect and Win Game Prize has five (5) unique Game Pieces. Four (4) of the five (5) Game Pieces will be awarded regularly to entrants. However, there will be a limited number of five (5) of the fifth Game Pieces ("Rare Game Piece"). Each Rare Game Piece will be associated with a random, computer-generated winning time during the Promotion Period. If you are the first player to play at or after the randomly generated winning time you will be awarded a Rare Game Piece. Once you have collected all five (5) Game Pieces, you will be a potential winner of a Movie Night Prize Package.

If any potential Instant Win Game winner and Collect and Win Game Prize winner cannot be contacted, fails to provide any other requested information within the required time period, or if prize is returned as undeliverable, potential winner forfeits prize. In the event that a potential Collect and Win Game Prize winner is disqualified for any reason or forfeits the prize, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible Game plays. Unclaimed Instant Win Game Prizes will remain unawarded.

Limitations of Liability:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry or play is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Instant Win Game play or Collect and Win Game entry, if possible. Disputes:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court

for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
